6/30/25 Early Bird Jury applications must be received before 6/30/25 notification of acceptance by 7/7/25.

9/1/25 Fall Jury applications must be received before 9/1/25, notification of acceptance by 9/8/25.

# <u>Step Two</u> Once accepted and before 10/15/25 ALL Newly Accepted Artists should complete "Booth Selection Form for ALL Artists" found online at <a href="https://www.allpeoplesuu.com/winterfair-artist-info/">https://www.allpeoplesuu.com/winterfair-artist-info/</a> Booths are assigned "first come first served" so submit your choices as soon as possible. It helps us too.

- We need your first, second and third choices.
- Payment will be requested at the time we email you confirmation of your booth assignment.
- Booths are reserved only upon receipt of payment.
- See "Booth Selection Form ALL Artists" for payment deadlines to reserve your booth.

**NOTE:** Indoor Booths are in two church buildings with a short walk between the two. Outdoor Bold & Cold booths are on the labyrinth between the two church buildings.
