Criteria for jurying is, a) design excellence (personal expression, innovation, aesthetic quality), b) craftsmanship (handling of the media, control of the style of work), and c) suitability (does the look of this work and the booth fit the perceived quality of Winterfair). These are standards that our customers have come to expect.

NOTE:

Two artists may share booth space if pieces complement or blend with each other, but they must jury individually.

Two artists creating one body of work jury as one unit.

Your name will be placed on the jury list only when we receive your jury application, images and jury fee.

Jury Application deadlines for New Artists

JULY 31 Applications must be received **before 7/31**; notification of acceptance by Aug. 7.

AUGUST 31 Applications must be received **before 8/31**; notification of acceptance by Sept. 7..

Step Two

Once accepted and before **OCTOBER 1** , Newly Accepted Artists complete “WINTERFAIR APPLICATION” found online by clicking this link [WinterFair! Information](#)

- **Booth Payment will be requested** at the time we email you confirmation of your booth option(s).
- Booths are assigned “**first come first served**” so apply as soon as possible.
- **Booths are reserved** only upon receipt of payment.

NOTE: *WinterFair! fills two buildings with 70+ artists, the Church Building and the Justice Center Building (farmhouse). It is a short well-lighted walk from the Church Building past Bold and Cold Artists on our labyrinth to the Justice Center Building.*
